## **Continuing Education Credits (ADMCE1)**

MAHTA bylaw 4.3 - Continuing Education *“A member must complete a minimum requirement of continuing education credits each year to maintain registered membership.”*

**The minimum requirement of continuing education credits is 10 credit hours/year. These credits can be obtained as follows:**

- 1) **Seminars - 1 credit / speaker hour.** This includes lunchtime seminars, conferences, wetlabs and workshops as approved by MAHTA. MVMA, other provincial association seminars, and any large North American conferences are pre-approved for credit. PROOF of attendance is required!
- 2) **Transcripts from MAHTA Seminars - 1/2 number of specified credits to a maximum of 3 CE credits per year.**
- 3) **Public Speaking Engagements - 1 credit / speaker hour.** Must be educational and promote the AHT field (PROOF REQUIRED).
- 4) **Published Articles - 2 credits / article.** The article must be published in the MAHTA newsletter or any other publication approved by MAHTA.
- 5) **Published Articles with Quiz - 3 credits / article with quiz.** The article must be published in the MAHTA newsletter or any other publication approved by MAHTA.
- 6) **C.E. Quizzes – 1/2 credit per quiz or as designated by publication.** This applies to quizzes submitted from Vet Tech magazine, CALAS National Newsletter, MAHTA Newsletter, or any other source approved by MAHTA.
- 7) **Computer on-line or various media outlets - however many number of credits deemed fair.** This may be obtained through webinar, video or audio and must be verified by examination.
- 8) A maximum of 3 CE credits may be from workshops/seminars indirectly related to animal health and welfare. Eg: management/accounting courses.

**It is each individual AHT’s personal obligation to maintain their own C.E. certificates and information for submission! Therefore it is MANDATORY to submit C.E. certificates for ALL the C.E. that you are claiming, or MAHTA will not be able to issue credits accordingly. If you have a CE credit that does not fit into the above categories please submit to the office for approval WELL BEFORE RENEWAL TIME to ensure Board has sufficient time to examine and approve. Thank you!**

- i. Is a graduate of a minimum 2 year AHT Diploma Course.  
**\*New members please enclose a copy of your diploma.\***
- ii. Is a resident of Manitoba.

(This membership is granted on a temporary basis, pending passing of the National Registration Exam for Animal Health Technologists.)

### 3. Associate Member

- i. Is a graduate of a minimum 2 year AHT Diploma course.  
**\*New members please enclose proof of graduation.\***
- ii. Does not reside in Manitoba.

### 4. Sustained Member

- i. Is a graduate of a minimum 2 year AHT Diploma course..
- ii. Has successfully completed the National Registration Exam.
- iii. Is not currently practicing in a facility that employs RAHTs (i.e. maternity leave, leave of absence, etc.)  
(This membership is granted for a maximum 2 year period before returning to active status.)

### 5. Student Member

- i. Students currently enrolled in a minimum 2 year AHT Diploma course.  
**\*Please submit proof of enrollment.\***
